

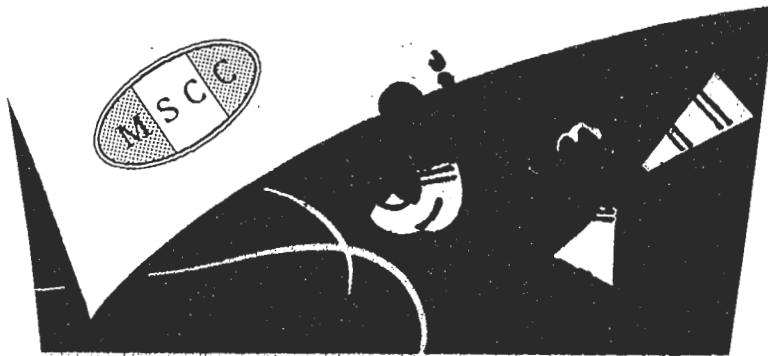

MSCC GENERAL AND EXECUTIVE MEETING MINUTES August 6, 2008

Brian McNamara called the meeting to order at 7:51 PM at Warrilow's in Ferndale. Members in attendance were Bill Siess, Judy Siess, Tony Buglione, Dave Rodier, Brian McNamara, Roger Campbell, Derek Watkins, John F. Cowall, and Rick Bohn.

MINUTES: Judy moved to approve the minutes from the last meeting, Derek seconded, all approved.

MEMBERSHIP: Judy reported we have 40 paid members. There are 2 pending members, Damon Humpries, and Chris Mackay. They need to attend and volunteer to work at an event in order to be voted into the MSCC.

**NOTICE: The 2008 dues will expire October 31, 2008.**

We did not have a drawing for the coveted mylar badge.

TREASURER'S REPORT: Everything is good. We paid John F. Cowall. John moved to spend \$200 on additional speakers and amplifiers. Brian tabled the motion and said he will research the prices of equipment. Plan on getting something over the winter. We need to budget money for next year, also.

COUNCIL REPORT: The Alfa Romeo Owners Club (AROC) asked to have their September 28 autocross be sanctioned by the Council as a Champ event. The Corvette Club of Michigan (CCM), the Ford Motorsports Club (FMC), and the AROC voted in favor. The MSCC asked to have our October 26 autocross be sanctioned by the Council as a Champ event. The CCM and the FMC voted in favor. Derek moved to have the MSCC vote in favor of both sanctions. John Cowall seconded. All approved.

EVENTS: Derek will chair October 12. Judy may not be there. Brian will chair October 26. Judy asked if we need porta-johns. Everyone said "YES!" John recommended repositioning the timing van in order to allow for a different course design and still allow proper positioning of the equipment.

OLD BUSINESS: Judy said we used to have two meetings per month. Over the years, we combined two into one. John said we combined the two meetings into one meeting because we don't get enough general members to justify a separate meeting. Brian will call Tracy at City of Detroit to follow-up regarding the bouquet of chocolate covered fruit and confirm the MSCC will have an autocross on Belle Isle on October 26. Judy says somebody owes money for the annual auction and a sweatshirt. **If you owe money to the MSCC, please send the payment to Judy ASAP.**

NEW BUSINESS: The MSCC needs to pay \$20 to the State of Michigan for our incorporation. Bill Siess moved to approve. John Seconded. All approved. Bill Siess found a source for colored masking tape. John Cowall bought shoe polish.

Whenever people renew their membership, they will need to go to the Web site to read the current Gudgeon Pin, They will not receive anything in the mail. It's too expensive to send notifications of elapsed dues and receipts of paid dues. Receipts will be given out the next time the payor and payee are together.
